The new **Arizona Quality Standards for Out-of-School Time Programs** were designed as a tool to strengthen your program and enable you to better meet the needs of Arizona's youth.

More than **340** out-of-school time programs signed the **Make it Count Pledge** since it was first announced on May 1. Signing the Pledge indicates a program's commitment to using the Arizona Quality Standards for Out-of-School Time Programs as part of their continuous quality improvement process.

The Quality Standards are meant to be used to:

- \* Foster a community conversation among parents, educators, program providers and funders about what quality looks like in out-of-school time programs
- \* Establish benchmarks for program improvement
- \* Identify and develop strategies to address program gaps and maximize impact
- \* Encourage and expand partnerships where needed
- \* Determine effective resource allocation in budgeting and program planning
- \* Promote individual program strengths to families.

## 2014 Arizona Out-of-School Time Advocate Results Are In!



Throughout the past six weeks, AzCASE reached out to candidates across the state, and asked them to **pledge their support for Arizona Out-of-School Time youth programs**. We are very excited to share the results.

Candidates for Congress were asked to complete a three-question survey, regarding their support for:

- \* The Child Care and Development Fund (CCDF)
- \* 21st Century Community Learning Centers, and
- \* The Supporting Afterschool STEM Act

We received responses from candidates in 7 districts, including Rep. Ann Kirkpatrick, Rep. Ron Barber, Rep. Raúl Grijalva, Rep. Kyrsten Sinema, and every candidate running in District 7. Candidates for the State Legislature, as well as Superintendent of Public Instruction, were asked to sign the **Arizona Out-of-School Time Pledge**, and become Arizona Out-of-School Time Advocates. **28 Legislative Candidates** representing 15 Districts, as well as Superintendent for Public Instruction Candidate David Garcia, signed on as Arizona Out-of-School Time Advocates.
