#### **Exhibitor Package**

#### The exhibitor fee includes:

#### Ad Art Work Guidelines

- Advertising materials may be mailed or submitted digitally on CD or via e-mail attachment by Friday, October 5<sup>th</sup>.
- Use of art work received after that date is not guaranteed.
- Acceptable file format is high-resolution JPEG (300 pixels per inch is recommended)

### Exhibitor and Advertiser Terms & Conditions Assignment of Exhibit Space

Space will be assigned to exhibitors in priority order based on receipt of the contract. Exhibit Management reserves the right to transfer assignments when such action is deemed to be in the best interest of the total Exhibition.

#### **Electricity and WiFi**

Exhibitors requiring access to electricity must indicate on the Sponsor & Exhibitor Agreement. Access to electricity may be purchased from the Phoenix Convention Center in advance of the event. AzCASE will provide exhibitor with the order form upon receipt of the Exhibitor Agreement & Advertiser Agreement. Wireless internet access is available for purchase on site on the day of the conference.

#### **Shipping**

The Phoenix Convention Center recommends Exhibitors ship their items to the FedEx closest to the Phoenix Convention Center, which is scheduled to deliver packages and should be open on the day of the conference. AzCASE can provide exhibitors with the shipping address upon request. AzCASE cannot accept any packages or deliveries on behalf of vendors.

#### **Payment**

Exhibitor/Advertiser Agreements submitted prior to 9/21/18: Payment must be received by AzCASE within 30 days of agreement submission.

Exhibitor/Advertiser Agreements submitted 9/21/18 and later: Payment must be received within 3 business days OR a copy of the relevant approved purchase order must be received within 1 business day, with payment then received within the following 10 business days.

Failure to adhere to these payment terms may result in the forfeiture of exhibitor and/or advertiser space.

#### Conduct

Exhibitor is expected to maintain a professional demeanor during the event and is solely responsible for keeping rental space free from any condition that may be dangerous to attendees. AzCASE shall not be liable for any loss, theft, damages or injuries. Should you need to be away from your table please be sure that valuables such as purses and cash boxes are removed.

#### Restrictions

Phoenix Convention Center rules require that any selling of merchandise be pre-cleared prior to event date. Additionally, the conference exhibit hall is subject to all City of Phoenix and Phoenix Convention Center laws, rules and restrictions. Please consult AzCASE with any questions regarding the compliance of your exhibit. Requests for advertising or exhibit fee refunds will not be considered after September 1, 2018.
